President's Corner December 2015

It's almost December, the end of our association's fiscal year and an eventful one.

One of the most important events has been changing the name of our community to Lansdowne Woods of Virginia. This also required that we change the legal name on all Riverbend's official documents.

Another milestone is that we have cleaned up our old financial records, and now maintain current and accurate financial files. A big thank-you to Ruth, Treasurer and Pricilla, Budget & Finance Moderator for persistent determination, and thanks also to our manager Sandy, who brought a deep knowledge and professionalism to our financial table. We are all indebted to them for their efforts.

A few project updates:

- 1) Our roof project status: We are creating an RFP (Request for Proposal). Our Building Facilities Committee has outlined what we desire and it is now in the hands of our attorney. This first RFP will go to two engineering firms. They will complete the RFP and return it to us so we can select which of the two firms will guide us through the rest of the roof project.
- 2) The BOD has received recommendations from both Budget & Finance and Building Facilities Committees to approve and sign the contract with KGS to do roof repair until full replacement occurs. We are on their schedule to begin shortly after Thanksgiving.
- 3) Comcast has given us a contract to establish five years of television service. It was

missing an agreement to upgrade our service during the duration of the contract. It was their oversight and will be forthcoming. Then it will go to our attorney for his approval. Comcast will begin upgrading our television service after the contract is signed.

- 4) At our most recent BOD meeting we presented the by-law change that will require a vote by all Riverbend unit owners. The by-law change is intended to allow us to add internet service to our Comcast contract. Perhaps one of the flaws in the updated by-law proposal is the line "including but not limited to." Many folks have indicated that this boilerplate line, that is included in many legal documents, is too open-ended. Based on recent history, here at Riverbend, these owners would feel more comfortable if that line were left out. I, and the rest of your board, understand this concern so we will revisit the proposed change and consider removal of that line from the proposal. When we have received attorney approval, we will mail the proposed change and update to our by-laws to all owners. Remember, it takes a 67% majority to pass a by-law change.
- 5) Last month I described the issue with our mailbox locks. Sue Wiggins's son, a locksmith in West Virginia, stopped by to take a look. He believes that he may have found a replacement part for the locks. Sandy has ordered one to see if it can be modified to work as a reliable replacement part. We will keep you informed.
- 6) Thank you to the many volunteers who have agreed to serve on our committees. Your BOD has approved all requested positions and has designated a Board Liaison for each committee. The BOD also agreed to merge the Covenants and Rules Committees. The Covenants Committee has legal standing in our by-laws. The Rules Committee was created to assist the Board and the

Covenants Committee. At the next BOD meeting we will vote to disband the Rules Committee. A review of our Pet Policy will be an early agenda item for the Covenants Committee.

7) In January, Sandy and I will meet with all the committees to present how they can function with a consistent format.

As always, feel free to sit in on any and all committee meetings.

I wish you all a very special Holiday Season. We are a community with many views of the world and of many faiths. So, I wish you all a very Happy Hanukah, a Joyous and Merry Christmas, a Happy Kwanzaa, a Happy Solstice. 
Volunteers Needed!

Community Services

Abraham Lincoln Exhibit:

The Loudoun County Public Library system is currently hosting an exhibit and related series of programs on "Lincoln, The Constitution and the Civil

War" at the Rust Library through December 18. 2015. The 1000 square feet display consists of five exhibition areas which chronologically examine Lincoln's President leadership Constitutional vision steered the nation to deal with three intertwined crises of the Civil War, i.e. the secession of Southern states, slavery, and wartime civil liberties. The remaining program related to this exhibit is "Music from the Civil War - Blue and Gray in Black and White," scheduled for Sunday, December 13, at 2:00 p.m. This program is described as "soulful music and colorful anecdotes and personal stories relating the causes and events of the American Civil War," and includes "poignant humorous insights into charismatic the war." personalities of For additional information about the Lincoln exhibit and / or its related program of Civil War music and anecdotes, contact the Rust Library (380 Old Waterford Road NW, Leesburg) at www.library.loudoun.gov or call 703-777-0323.

Scams Revisited:

The Loudoun County Sheriff's Office recently alerted residents about a number of scams and frauds that have been taking place throughout Loudoun County. In many of these instances, the perpetrators very convincingly pose as law enforcement or government officials who inform victims that they owe some type of fine. In many of these cases, the victims are persuaded to load money into a prepaid card and provide the scammers with the card information.

Other scams targeting senior citizens that increase during the fall season include investment fraud, i.e. sales pitches for bogus investments; and charity cons, i.e. fake charities supposedly raising money to

help sick or needy victims or to help fire and police personnel. To get information about professional backgrounds of brokers, brokerage firms, investment advisor firms and advisors, one website option is www.brokercheck.finra.org.

. To help gauge a charity or its credibility, go to www.navigator.org or www.give.org .

Scam alerts repeatedly recommend that you not provide any payment information over the phone unless you placed the telephone call. Also, if you did not provide your email address to an organization, assume its email solicitations are scams; and do not click on links from unknown senders.

Virginia Caregivers' Legislation:

An article in a recent "AARP Bulletin" reported that Virginia lawmakers passed the Caregiver Advise, Record, Enable (CARE) Act which took effect July 1, 2015. This law requires that hospital staff inform a patient's designated caregiver about discharge plans and also must show the caregiver how to perform follow-up care needed at home, such as managing medications or dressing wounds. An AARP study found that almost half of Virginia's over one million family caregivers performed medical or nursing tasks after their family member was discharged home, but most said they received little or no training on how to do those tasks.

Inova Loudoun Hospital Patient Safety Award:

All five of northern Virginia's Inova Hospitals, including Inova Loudoun, recently were graded "A" in their national safety ratings by the Leapfrog Group, an independent hospital watchdog organization whose mission includes rewarding hospitals which have a proven record of high quality care. The Leapfrog Hospital Survey compares hospitals' performance on national standards of safety, including incidence of medical errors, injuries, accidents and infections.

Piedmont's Table

Our next door "neighbor," Lansdowne Resort, has several restaurants including Piedmont's Table in the Golf Clubhouse. We enjoyed a Saturday night dinner, including "Drunken Goat Cheese" for a starter, entrees of chicken breast, short ribs, filet mignon, and amazing planked salmon. For dessert we sampled cheesecake topped with strawberry rhubarb sauce and a blueberry crisp with lemon ice cream.

The waiter had never heard of a Brandy Alexander, but the bartender came through with a tasty version. Many wines are available by the glass; hard cider is crisp and refreshing. The generous bread basket included several different warm, soft rolls and spreadable butter. Our Goat Cheese starter was light on cheese (3 small slices) but included lots of grilled bread, fig preserves, whole-seed mustard, honey produced at the resort, sliced tart apples, and a sprinkling of chopped pecans.



The chicken breast was topped with a lovely lemon sauce, but was dry and overcooked.

The steak, on the other hand, was cooked perfectly, served with a mild horseradish potato puree.





Short ribs were fall-apart tender, served

with a "mushroom bread pudding" which was unusual but quite nice.



Best of all was the salmon: tender, juicy, beautifully spiced and so delicious! Entrees came with a mélange of starchy winter vegetables. We

identified cubes of sweet potato, winter squash, white potato, beets? mushrooms? Only the chef knows for sure.



Desserts were good. Blueberry crisp

comes in its own little tart crust, loaded with fruit.



The lemon ice cream is a nice addition.

The cheesecake was good; several whole strawberries

decorated the top, but rhubarb was difficult to detect.

Entrées are mostly in the mid \$20's. Filet is \$34. Desserts are \$8 to \$9. Our Lansdowne Woods 10% discount is calculated on food only.

During the winter, Piedmont's hours are limited, although Pub 46, with a more casual menu, is open. Call <u>703 726-1450</u> to check.

Board Highlights:

This is an unofficial summary. Once the members have approved the minutes, they will become official record and can be viewed online or in the Riverbend lobby.

At their November 19 meeting, the Board took the following actions:

- Approve the June 4, 2015 Replacement Reserve Study, as final, after the list of changes are made and incorporated into the study.
- The lawyer has been asked to produce an RFP for the Engineering terms of the roof contract.
- Wait until days are dark earlier to check which street lights are on each building's electric meter.
- Approve the Comcast agreement for a term of five years after attorney review and revisions and agreement allows for renegotiation at any time during the term of the agreement for additional services.
- Approve proposed amendments to the bylaws related to bulk service agreements for television, internet, and telephone services.
- Discuss policing parking lot. Does the Board wish to monitor the parking lot? The Board declined.
- Approve the Budget & Finance Committee request regarding excess income from 2015.
- Approve 2016 Committee Members. Appoint Committee Chairs and Board Liaisons.
- Approve to combine the Covenants and Rules Committees.
- Decline approval of registration of Unit Owner/Resident Personal Service Contract policy.
- Approve 2016 Annual Administrative Calendar.
- Pet Policy Resolution No.10 will be sent to Covenants Committee for review.
- **Executive Session:** Approve the write off of a delinquency account.
